




As parents – you may be wondering what you should do to help your kids be successful in school. There are the obvious things like: going to bed on time, be involved in your children's learning, reading with your children.... Here are some other

tips I would like to share to help your children grow and develop their thinking skills:

- 1. Talk with your child about his or her day but guide the discussion. Ask questions like: "What did you learn today?"
- 2. Encourage failure (What??) Kids need to know that failure is okay and is an opportunity to learn. Each time they fail they learn more about perseverance and challenges.
- 3. Praise the process compliment how they worked or accomplished their goal.
- 4. Remind them that their brain is growing each time they learn something new or push through a tough lesson – they are becoming more intelligent! This is what we want!
- 5. Help them change their dialogue. Replace negative self talk with words like: "I can't do this now but I am learning." And -model that talk yourself!

The ALICE Crisis Response Program

At Cedar Mountain, the safety of our students, staff, and visitors is among our highest priorities. We work collaboratively to foster a safe, secure learning environment as we deliver on our mission to educate, inspire and empower all of our students.

This year, Cedar Mountain has started the implementation process of a more proactive approach when responding to threats of school violence. Such events may include active shooter situations and other imminent threats to safety that require schools to lockdown. District and school administrators, along with all staff, are being educated in a program called ALICE response. This is a less passive approach to a crisis situation that provides our staff more options based on the circumstances of the incident. The ALICE acronym stands for Alert, Lockdown, Inform, Counter and Evacuate. The threat of an active shooter or intruder in our schools is rare but, in today's society, a reality. Therefore, empowering our staff with proactive response strategies, rather than a passive one-size fits all approach is a positive change to our district's emergency response and crisis management plans. Ultimately, we hope to never have to utilize an emergency response plan, but in the event we do, please be assured that staff will be well prepared to act in the best interests and safety of our students.

While continuing the excellent tradition of a high quality education delivered in a friendly personal environment, Cedar Mountain has several changes and innovations for the current year while. Here are some of what is changing and what is not changing:

• Cedar Mountain has 19 staff members who have been with Cedar Mountain for 20 years or more. They are: 20th Year - Molly Lorang, Monica Sandmann, and Jeannie Tauer; 21th Year - Joel Christianson, Sue Luna, and Karen Malecek; 22st Year - Charlotte Hoffmann and Karen Lussenhop; 24nd Year - Peggy Mages and Gayle Hoffmann; 25th Year



- New teachers include: Josh Guetter elementary special education; Paige Pautzke, English and Language Arts; Heidi Schroden - Biology and Life Science; Kristin Rossow - Grade 5; Jeremiah Miller - Earth Science and Chemistry; Nicholas Schaub - Social Studies; Brady Yrjo - Elementary Phy Ed; Josiah Torvik - Elementary Music and Global.
- The Cougar Cub Child Care Center opened last December. While the infant program is currently full, there are openings in the toddler and preschool programs. For more information, contact the Center Director Jody Rose at 507-557-2254.
- The Cedar Mountain preschool program was expanded and awarded a 4 Star Parent Aware designation! This will allow our school to qualify to receive Pathway II Scholarships again for this year! Parent Aware shows everyone that our program has assessments, curriculum and training that is approved by the Minnesota Department of Education.
- We are using a new student information system this year. Cedar Mountain is converting from the JMC program to the Infinite Campus student information system. A big part of this change is the parent access part of the program. There will be more information available to parents (lunch balances and grades), and the ability to pay athletic fees and lunch online.
- Each K-5 classroom will have an iPad cart with enough devices for each child. Teachers will be using these to enhance instruction. Elementary iPads will be used in school only – they will not be sent home.
- Students in grades 6-12 again will have a Chromebook to use for their classes. The devices will be distributed to the students prior to the first day of school.
- · Alissa Steve is back as our Technology Integration Leader. She will again spend time in both buildings as a resource to staff to help them utilize technology in their classrooms.
- Be sure to check out the new wall mats on the gym wall in Morgan.
- Cedar Mountain offers many athletic and academic opportunities to students. This includes: volleyball, football, cross country, wrestling, boys and girls basketball, spirit squad, golf, tennis, junior high softball, junior high baseball, track, FFA, Knowledge Bowl, Mock Trial, National Honor Society, Speech, Blue Crue (student council), WE (Women Empowerment), STARS (students thinking about responsible solutions), Yellow Ribbon Suicide Prevention Program, Blue Crue Tue (elementary student council), school play, pep band, elementary Triple A program, and Community Education activities.
- This is the third year with the Ramp Up to Readiness program. Ramp-Up to Readiness is a school-wide advisory program that features an engaging and interactive series of activities designed to help all students graduate from high school ready for postsecondary success.

All of the positive changes for the upcoming school year are products of our innovative team of educators!

What's in a Meal?

What is included with a School Breakfast

(multiple options are offered in each category):

Students must select at least three food items from the list above to be considered a full meal, 1/2 cup of fruit is required as one of the choices.

What is included with a School Lunch:

- Fruit
- Vegetable
- Grain

- Meat/Alternate
- Milk

Our lunches include UNLIMITED TRIPS TO THE SALAD BAR.

Elementary students are served a full lunch each day. Grades 6-8 may choose a full lunch OR must choose at least 3 of the 5 components to be considered a full meal and it must include 1/2 cup fruit or vegetables.

Grades 9-12 must choose at least 3 of the 5 components to be considered a full meal and it must include 1/2 cup fruit or vegetables.

Regardless of your lunch status (Free, Reduced or Paying), extra milks and extra entrees are an ADDITIONAL COST.



Preschool Options

3-Year-Old (AM) School Readiness Class

This class is offered in Franklin & Morgan and is for students who are entering Kindergarten in 2019-20.

Days & Time: Mondays & Wednesdays from 8:30 AM - 11:00 AM

Location: Morgan & Franklin

Cost: \$60 per month - billed the month prior to services

4-Year-Old (PM) School Readiness Class

This class is offered in Franklin & Morgan and is for students who are entering Kindergarten in 2018-19.

Days & Time: Mondays & Wednesdays from 12:45 PM - 3:15 PM

Location: Morgan & Franklin

Cost: \$60 per month - billed the month prior to services

Kindergarten Jumpstart - Franklin Site

This program will be held all day every other Friday in Franklin for Cedar Mountain students going to kindergarten in 2018-19. This class will help prepare your child for kindergarten by teaching various routines such as using the lunchroom, visiting specialists in other parts of the building such as Phy. Ed, computer lab, library etc..., emphasis will also be on letter recognition, phonemic awareness, and math skills to prepare for the transition to kindergarten. Transportation is unique to this program, you will work with your child's teacher to plan a smooth transition for your child.

Our school provides healthy meals each day. Elementary breakfast costs \$1.00; Elementary lunch costs \$2.60. Middle school/High school breakfast costs \$1.40; Middle school/High school lunch costs \$2.70. Your children may qualify for free or reduced price meals.

To apply for free school meals, complete the enclosed Application for Educational Benefits following the instructions. A new application must be submitted each year. If you don't qualify now, you may apply at any time during the school year. Your application also helps our school qualify for education funds and discounts.

State funds help to pay for reduced-price school meals, so all students who are approved for either free or reduced-price school meals will receive school meals at no charge. State funds also help to pay for breakfasts for kindergarten students, so all participating kindergarten students will receive breakfasts at no charge.

Who can get free school meals? Nondiscriminatory policy

Cedar Mountain Schools are committed to providing equal education and employment opportunities to all persons and do not discriminate on the basis of race, color, creed, religion, national origin, sex, marital status, with regard to public assistance, disability, or any other group or class against which discrimination is prohibited by Titles VI and VII of the Civil committed Rights Act of 1964, Title IX of the Educational Amendments of 1972, Minnesota Chapter 363, and other applicable state or federal laws. Annual notification of rights, protection, and privacy of student records

Pursuant to the requirements of state and federal law, the following constitutes the Cedar Mountain School District's annual notification to parents and students regarding data privacy practices.

The Cedar Mountain School District has adopted a student record data privacy policy incorporating state and federal requirements as to data privacy rights in student education records. In summary the policy provides:

Privacy rights. Educational records which identify or could be used to identify a student other than directory information may not be released to members of the public without the written permission of the parent or guardian of the student, or student age 18 or older if the student attends a post secondary institution. This general rule is subject to specific and limited exceptions which cannot beset out here due to limitations of space, but which are set out in the complete policy.

Directory information. Directory information includes the following: Students' name, student's address, student's telephone number, date and place of birth, names of the student's parents, participation in official recognized activities, grade levels completed, weight and height of members of athletic teams, dates of attendance, degrees and awards received, the most previous educational institution attended, and photo of the student, if available.

Inspection of records. Parents of a student, or a student age 18 or older, may request to inspect and review any of the student's educational records except those which are by state and federal law made confidential. The school district will comply with the request immediately, if possible, and if not, within five working days. In certain special circumstances an additional five working days may be required in order to comply. Copies of the record may be obtained at a reasonable fee as established by the school district.

Challenge to accuracy of records. A parent, or student age 18 or older, who believes that specific information in the student's educational record is inaccurate, misleading, incomplete or violates the privacy or other rights of the student may request the school district to amend the record in question.

If, as a result of this review, it is determined that the challenged record is not inaccurate, misleading, incomplete or in violation of the privacy or other rights of the student, the parent, or student age 18 or older, will be notified of their rights to place a statement with the decision of the school district.

The decision of the superintendent/school board is the final decision of the school district and may be appealed under the provision of the state Administrative Procedure Act, Minn. Stat. C15, relating to contested cases.

Transfer of records to other schools: The school district forwards educational records of a student to other schools and school districts in

which a student seeks or intends to enroll upon request of that school or school district. A parent of a student who is 18 years of age may request and receive a copy of the records which are transferred and may, pursuant to this policy, challenge the accuracy of the records. The district does not, however; notify parents of students age 18 or older prior to such a transfer.

Complaints for noncompliance: Parents or students age 18 or older who feel there has been a violation of the rights accorded them' may submit written complaints to the:

This review of the data privacy rights of students in the educational records maintained by the Cedar Mountain` School District is intended only to be a summary of the provisions of the district policy, and applicable state and federal law.

Notice Concerning Use of Pest Control

Our district utilizes a licensed, professional pest control service firm for prevention and control of rodents, insects, and other pests in and around the district's buildings. Their program consists of:

- Inspection and monitoring to determine whether pests are present and whether treatment is needed.
- Recommendations for maintenance and sanitation to help eliminate pests without the need for pest control materials.
- Utilization of non chemical measures such as traps and screening; and,

Application of EPA registered pest control materials when needed. Pests can sting, bite, cause contamination, damage property, and spread disease; therefore, we must prevent and control them. The long term health effects on children from the application of such pest control materials, or the class of materials to which they belong, may not be fully understood. All pest control inspections and possible treatments is available for review or copying at each school office. A similar estimated schedule is available for application of herbicides and other materials to school grounds. Parents of students may request to receive, at their expense, prior notification of any application of a pest control material, should such as application be deemed necessary on a day different from the days specified in the schedule.

Notification of asbestos abatement

As a result of recent federal legislation (Asbestos Hazard Emergency Response Act AHERA), each primary and secondary school in the nation is required to complete a stringent new inspection for asbestos and to develop a plan of management for all asbestos containing building materials. The Cedar Mountain School District has a goal to be in full compliance with this law and is following the spirit as well as the letter of the law. As a matter of policy, the district shall continue to maintain a safe and healthful environment for our communities youth and employees.

In keeping with this legislation, all buildings in the Cedar Mountain School District were inspected by EPA accredited inspectors and samples were analyzed by an independent laboratory. Based on the inspection, the school prepared and the state approved a comprehensive management plan for handling the asbestos located within its buildings safely and responsibly.

Furthermore, the Cedar Mountain School District has completed its 3 year Re-inspection required by AHERA. Your district buildings, where asbestos containing materials were found, is under repair, removal, and operations and maintenance.

Federal law requires a periodic walk through (called "surveillance") every six months of each area containing asbestos. Also, the law requires for all buildings to be re-inspected three years after a management plan is in effect. This will be accomplished under contract by Airtech Environmental. Short term workers (outside contractors – i.e. telephone repair workers, electricians and exterminators) must be provided information regarding the location of asbestos in which they may come into contact. All short term workers shall contact the lead maintenance person before commencing work to be given this information.

The Cedar Mountain School District has a list of the location(s). type (s) of asbestos containing materials found in that school building and a description and timetable for their proper management.

NOTICE OF COMPLIANCE WITH THE ADA It is the policy of CM Schools to comply with the provisions of the Americans with Disabilities Act (ADA). EMPLOYMENT BACKGROUND CHECKS

In accordance with Minnesota Statute it is the responsibility of the district to notify students and parents of our policy regarding employment background checks. It is the policy of the district to require a background check of every new employee. It is also the practice of the district to require background checks of volunteers depending upon their nature of their volunteer position. Employment Background Check Policy 404 is also available at the district office.

SPECIAL EDUCATION EVALUATIONS FOR HOME-SCHOOLED OR PRIVATE-SCHOOL STUDENTS

In response to the Individuals with Disabilities Education Improvement Act (IDEIA 2004), Minnesota School Districts must demonstrate that "all children with disabilities, including children with disabilities attending private schools, regardless of the severity of their disabilities, and who are in need of special education and related services, are identified, located and evaluated." This responsibility extends to children with disabilities who are educated at home or in non-public schools.

Upon request, your local public school will provide information to concerned parents on specific disabilities including information about the educational or behavioral characteristics of each disability. Parents who believe their child may indeed have a disability may request information on how to arrange for an evaluation through the district's special education staff.

Parents of students who are evaluated and are found to be eligible for special education services will become part of a team which will develop, implement, and monitor the effectiveness of a Service Plan to meet the identified needs of their children.

If your child is home schooled and you have questions or would like to receive information about specific disabilities or an evaluation: please contact the principal of the school your child would be attending if he/she was enrolled in your resident district public school and was not being educated in your home.

If your child is being educated in a private school and you have questions or would like to receive information about specific disabilities or an evaluation: please contact the principal of the school building your child would attend in the district where the private school is situated.

Parent and student rights in identification, evaluation, placement

The following is a description of the rights granted by federal law to students with handicaps. The intent of the law is to keep you fully informed concerning decisions about your child and to inform you or your rights if you disagreed with any of these decisions. You have the right to:

- Have your child take part in and receive benefits from public education programs without discrimination because of his/her handicapping condition.
- Have the school district advise you of your rights under federal law.
- Receive notice with respect to identification, evaluation, or placement of your child.
- Have your child receive a free appropriate public education. This includes the right to be educated with non handicapped students to the maximum extent appropriate. It also includes the right to have the school district make reasonable accommodations to allow your child an equal opportunity to participate in school and school related activities.
- Have your child educated in facilities and receive services comparable to those provided non handicapped students. Have your child receive special education and related services if she/he is found to be eligible under the Individuals ;with Disabilities Education Act (PL 101476) or Section 504 of the Rehabilitation Act.
- Have evaluation, educational, and placement decisions made based upon a variety of information sources, and by persons who know the student, the evaluation data, and placement options.
- Have transportation provided to and from an alternative placement setting at no greater cost to you than would be incurred if the student were placed in a program operated by the district.
- Have your child be given an equal opportunity to participate in nonacademic and extracurricular activities offered by the district.
- Examine all relevant records relating to decisions regarding your child's identification, evaluation, educational program, and placement.
- Obtain copies of educational records at a reasonable cost unless the fee would effectively deny you access to the records.
- A response from the school district to reasonable requests for explanations and interpretations of your child's records. Request amendment of your child's educational records if there is reasonable cause to believe that they are inaccurate, misleading or otherwise in violation of the privacy rights of your child. If the school district refuses this request for amendment, it shall notify you within a reasonable time, and advise you of the right to a hearing.
- Request mediation or an impartial due process hearing related to decisions or actions regarding your child's identification, evaluation, educational program or placement. You and the student may take part in the hearing and have an attorney represent you. Hearing requests must be made to Independent School District No. 2754, Superintendent of Schools.
- Ask for payment of reasonable attorney fees if you are successful on your claim.

SECTION 504 NOTIFICATION

If a student is found to be a "qualified disabled person" under Section 504, a Section 504 Plan is prepared and implemented in accordance with the regulations of Section 504 of the Rehabilitation Act. The Section 504 Plan is designed to meet the individual educational needs of disabled students as adequately as the needs of non-disabled students and should be in adherence to provisions that include identification, evaluation, placement and notice. Implementation of an Individualized Education Program (IEP) in accordance with the Individuals with Disabilities Education Act (IDEA) is one means of meeting this standard. If a student does not qualify for an IEP, they may qualify for a Section 504 Plan.
